**FACULTY RECRUITMENT**

The National University of Educational Planning and Administration (NUEPA), established by the Ministry of Human Resource Development, Government of India, is a premier organization dealing with research and capacity building in planning and administration of education, not only in India but also in South Asia. Incumbents are required to undertake both teaching and supervision at M Phil. and Ph. D. levels. - (ii) A minimum of ten years of teaching and research or management experience in University/College/Research Institutions.
- (iii) Evidence of contribution to educational innovation and technology mediated teaching learning process.
- (iv) Evidence of experience in leading and managing, learning Management System and Virtual Learning Environment in large organizations.
- (v) Experience of guiding candidates for research at doctoral level.

An outstanding Professional, with established reputation in the field, who had made significant contribution to knowledge, in the concerned/allied/relevant discipline, to be substantiated by credentials.

- (iii) Experience of guiding candidates for research at doctoral level.

An outstanding Professional, with established reputation in the field, who had made significant contribution to knowledge in the concerned/allied/relevant discipline, to be substantiated by credentials.

## **4. Professor in National Centre for School Leadership (Contractual)**

- (ii) A minimum of ten years of teaching and research or management experience in University/College/Research Institutions. Experience of curriculum development, designing and delivering training and capacity development programmes, guiding student assessment.
- (iii) Evidence of leading research teams and carrying out empirical studies in the domain of school education and published work of high quality.

- (iv) Experience of guiding candidates for research at doctoral level.

An outstanding Professional, with established reputation in the field, who had made significant contribution to knowledge, in the concerned/allied/relevant discipline, to be substantiated by credentials.

**5. Associate Professor**

- (i) A Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed).
- (ii) Ph.D. Degree in Education/Social Sciences or other related areas.
- (iii) A minimum of 8 years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry excluding the period of Ph.D. research with evidence of published work and a minimum of 5 publications as books and/or research/policy papers.
- (iv) Contribution to educational innovations, design of new curricula and courses, and technology – mediated teaching learning process with evidence of having guided doctoral candidates and research students.

**6. Associate Professor in Centre for Policy Research in Higher Education (Contractual)**

**Essential Qualification:**

- (i) Good academic record with a Ph.D. Degree in Education/ Social Sciences or allied areas.
- (ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed).
- (iii) A minimum of 8 years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/Industry excluding the period of Ph.D. research with evidence of published work and a minimum of 5 publications as books and/or research/policy papers.
- (iv) Evidence of experience in carrying out empirical research in areas related to higher education.

**7. Assistant Professor in Centre for Policy Research in Higher Education (Contractual)**

Age: **Preferably below 35 years**

**Essential Qualification:**

- (i) Good academic record with a PhD degree and at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- (iii) Notwithstanding anything contained in sub-clauses (i) and (ii) above, candidates, who are, or have been awarded a Ph. D. Degree in accordance with the University Grants Commission

(Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.

**General Condition applicable to all posts:**

Professor – 37400-67000 with AGP of ₹ 10,000/-, (minimum monthly salary – 1,22,680/-)  
Associate Professor – 37400-67000 with AGP of ₹ 9000/- (minimum monthly salary – 1,08,160/-)  
Assistant Professor – 15600-39100 with AGP of ₹ 6000/- (minimum monthly salary – 53,600/-)
2. Eligible and interested candidates may submit their applications online alongwith their curriculum vitae including details such as qualifications, experience and other details etc.
3. Candidates currently employed in government/semi government organizations/ autonomous bodies will have to submit No Objection Certificate (NOC) at the time of interview.
4. Candidates from outside Delhi called for interview shall be paid TA as per entitlement for the posts of Professor and 2 AC train fare for other posts by shortest route.
5. Kindly use separate Application Form for each post.
6. Minimum requirements of qualifications and/of experience may be relaxed in respect of exceptionally outstanding candidate. The University reserves the right to fill up or not to fill up any or all the posts or to shortlist and select the candidates in any suitable position depending upon the qualification and experience required for the said posts.

**Conditions for regular positions:**

1. The services rendered on joining NUEPA after 1.1.2004 by those who are already covered under pension scheme in central universities/colleges and other institutions deemed to be universities under purview of UGC shall be permitted to continue to be governed under CCS (Pension) Rules, 1972 on joining of NUEPA.
2. The services rendered on joining NUEPA after 1.1.2004 by other than that stated at (1) above will be governed under new contributory pension scheme and no conversion shall be allowed.
