Nominations for the Maulana Abul Kalam Azad Chair

Nominations are invited for the Maulana Abul Kalam Azad Chair instituted by the Government of India, Ministry of Human Resource Development at the National University of Educational Planning and Administration.

The Chair will be equivalent to the post of Professor in the scale of pay of Rs.16,400-22,400 (with usual allowances), and the nominee is expected to work full time at NUEPA actively taking part in the University's research, teaching, training and other academic activities. Nominee has to be a distinguished scholar with a minimum of 15 years' experience of teaching and research with high quality published research work in areas related to school and higher education - the areas dear to the heart of Maulana Abul Kalam Azad.

Nominations to the Chair may be made by present and former heads of universities, institutions of national importance, other institutions of higher education and other eminent educationists. Nominations should include detailed **curriculum vitae** of the nominee along with a formal covering letter from the nominators.

Nominations may please be sent to the Vice-Chancellor, NUEPA by $30^{\rm th}$ November, 2008.

In additional to the details provided above, the following terms and conditions are applicable to the appointment to the Maulana Abul Kalam Azad Chair.

- The Chair position will initially be for a period of two years and might be extendable for another three years.
- For serving professionals, protection of the salary in the parent department along with leave salary, family pension contribution, etc. and deputation allowance.
- In case of retired/foreign professional, emoluments will be decided by the University on a case-to-case basis irrespective of any other superannuating benefits etc. drawn by the concerned professional.

- Since NUEPA does not have adequate residential facilities, the Chair (Professor) will be reimbursed HRA as per the rules of NUEPA.
- Residence at Delhi is compulsory during the tenure with entitlement to leave as applicable to the NUEPA faculty.
- The Chair, besides working for his/her project is also expected to engage in M.Phil. and Ph.D. Programmes, training activities of NUEPA and also in discussions, seminars, symposium, workshops, etc. organized by the University from time to time and contribute to the overall academic life of the University.
- At the time of joining NUEPA as the Maulana Abul Kalam Azad Chair of the National University, outstation scholars will be paid travel expenses by apex fare in a national carrier. The same would apply when the Chair leaves the University at the end of the tenure. Besides, telephone, internet, medical facilities, etc. will be provided to the Chair as per the rules of the University.
- In case of field work involved in the project undertaken by the Chair, the University will bear the expenditure as per NUEPA rules. However, daily allowance may not be permissible if the Chair decides to work in his/her hometown for the purpose of field study.
- The Chair will be governed by the rules and regulations of the university and shall be provided all those facilities as are applicable to the professors of the University.
