Admission to M. Phil. & Ph. D. Programmes, 2007-08

The National University of Educational Planning and Administration (NUEPA), fully maintained by the Ministry of Human Resource Development, Government of India, is a premier organization of its kind in South Asia engaged in research and training in planning and administration of all stages of education.

NUEPA offers **full-time M. Phil. Programme and both full-time and part-time Ph. D. Programmes** in educational policy, planning, finance and administration from a broader inter-disciplinary social science perspective. The focus areas of research cover school education, higher education, inclusive education, constitutional rights and law, management information system, etc. from both national and international development perspectives.

Eligibility and Application Process

- A candidate seeking admission to the M. Phil/Ph. D. programme shall have a minimum of 55% marks (50% for SC/ST candidates) or its equivalent grade in Master's Degree in Education, Social Sciences, Sciences, Commerce, Management, Law and allied disciplines from a recognized university.
- Candidates who are yet to clear their final examination at the Master's level are also eligible to apply. However, they have to submit the proof of having qualified in the examination latest by 31st May, 2007 as their selection for admission to M. Phil/Ph.D Programme will be subject to the above-mentioned eligibility conditions.
- The NET qualified candidates, who have been awarded Fellowships by the UGC-CSIR, with the above-mentioned educational qualifications can also apply.
- In addition, the **part-time candidates for Ph. D. Programme** should have at least two years of

teaching/research experience in educational planning and/or administration.

Government officials working in the field of educational planning and administration, with a minimum of 2 years of experience, are also eligible for the **part-time Ph. D. programme**.

How to Apply

Candidates may apply in the prescribed form, separately available for M. Phil. And Ph. D. Programmes, along with three copies of the brief write-up on the proposed research topic (in about 2500 words) to **the Registrar, NUEPA, 17-B, Sri Aurobindo Marg, New Delhi 110016**. The Application Form and the Prospectus can either be downloaded from our **website: www.nuepa.org** or obtained by post through a request along with a self-addressed stamped envelope of Rs. 20.00 addressed to the Registrar.

Mode of Selection

Short listed candidates will be called for test/interview/seminar presentation at NUEPA, New Delhi.

Fellowships

NUEPA offers fellowships (up to 10 in a year) for full-time Ph. D. Programme as per the UGC norms. NUEPA may also offer fellowships for M. Phil. Programme as per its norms.
