### FACULTY RECRUITMENT

The National University of Educational Planning and Administration (NUEPA), established by the Ministry of Human Resource Development, Government of India, is a premier organization dealing with research and capacity building in planning and administration of education, not only in India but also in South Asia. In recognition of the pioneering work done by the organization in the field of educational planning and administration, the Government of India has upgraded it to the status of a national university. Like any Central University, NUEPA is fully maintained by the Government of India. NUEPA being an academic institution, is actively engaged in research, training, consultancy and extension in educational planning and administration at all levels of education. Besides, it also acts as a clearing house for dissemination of knowledge through seminars, workshops, conferences, publications, etc.

The University has opening for various faculty positions at the level of Professor (37,400-67000 + AGP 10,000), and Assistant Professor (15,600-39100 + AGP 6000) which also includes special drive for recruitment to the post reserved for persons with disabilities at the level of Assistant Professor. Incumbents are required to undertake both teaching and supervision at M Phil. and Ph. D. levels. Besides, they are also required to undertake intensive research and training at school and higher education levels. Therefore, their specialization should necessarily fall in one or more of the following areas:

- 1. Educational Planning
- 2. Educational Administration
- 3. Educational Finance
- 4. Educational Policy
- 5. School and Non-formal Education
- 6. Higher and Professional Education
- 7. Educational Management and Information System
- 8. Training and Capacity Building in Education

### Essential Qualification/Pay Band + AGP/Age

# A. Professor (2 Posts) (₹37,400-67000 + AGP ₹ 10,000 {Minimum pay to be fixed at ₹43,000/-}), Age: preferably below 50 years.

**Mode of Recruitment:** Direct Recruitment (By advertisement/nomination/invitation) failing which deputation/transfer

## I). <u>Eligibility conditions for direct recruitment:</u>

- (i) An eminent scholar with Ph. D. qualification(s) in concerned/allied/relevant discipline and published work of qualify, actively engaged in research with evidence of published work with minimum of 10 publications as books and/or research/policy papers.
- (ii) A minimum of ten years of teaching experience of guiding candidates for research at doctoral level.
- (iii) Contribution to educational innovation, design of new curricula and courses, and technology mediated teaching learning process.

(iv) A minimum score stipulated in Academic Performance Indicators (API) based Performance Base Appraisal System (PBAS) set out in UGC Regulations with in Appendix III of UGC Regulations 2010.

### OR

An outstanding Professional, with established reputation in the field, who had made significant contribution to knowledge, in the concerned/allied/relevant discipline, to be substantiated by credentials.

### II). <u>Eligibility conditions for Deputation/Transfer</u>

- a) Officers/Academics from Central or State Governments, Universities, Professional and Research Institutions/bodies
  - a. Holding analogues post on regular basis; or
  - b. With 5 years regular service in post in the pay band of ₹ 37400-67000 + AGP 8700 from government source or 5 years regular service as Reader or in the post in pay band of ₹ 37,400-67000 with AGP 9000 or equivalent; and
- b) Possessing qualifications and experience prescribed for direct recruits. (Period of deputation shall not ordinarily exceed 4 years)

# B. Assistant Professor (1 Post {OBC} {PWD} {15600-39100 + AGP 6000}), preferably below 35 years.

### Mode of Recruitment: Direct Recruitment

#### **Eligibility conditions for direct recruitment:**

- (i) Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- (iii) Notwithstanding anything contained in sub-clauses (i) and (ii) above, candidates, who are, or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.

#### Persons with Disability

- (i) Hearing impairment:- The deaf are those in whom the sense of hearing is non-functional for ordinary purpose of life. They do not hear; understand sound at all even with amplified speech. The cases included in this category will be those having hearing loss more than 90 decibels in the letter ear (Pro-found impairment or total loss of hearing both ears).
- (ii) Orthopedically Challenged:- The orthopedically handicapped are those who have a minimum of 40% of physical defect or deformity which causes an interference with the normal functioning of the bones, muscles and joints including locomotor disability and cerebral palsy.

### **General Conditions:**

- 1. Those who are eligible and interested may submit their applications alongwith their curriculum vitae including details their qualifications and employment backgrounds etc.
- 2. Reservation for SC/ST/OBC and Persons with Disabilities (PWD) exist as per GOI/UGC/NUEPA norms.
- 3. Candidates already in employment under government/semi government organizations/ autonomous bodies should send their applications through proper channel.
- 4. Other things being equal, preference will be given to SC/ST/OBC/Persons with Disability as per Government of India instructions currently in force.
- 5. Candidates from outside Delhi called for interview will be paid single return second class train fare by shortest route.

### Notes:

- (i) The services rendered on joining NUEPA after 1.1.2004 by those who are already on pension scheme in central universities/colleges and other institutions deemed to be universities under purview of UGC shall be permitted to continue to be governed under CCS (Pension) Rules, 1972 on joining of NUEPA
- (ii) The services rendered on joining NUEPA after 1.1.2004 by other than that stated at (1) above will be governed under new contributing pension scheme and no conversion shall be allowed.
- (iii)Five non-compoundable advance increments shall be admissible at the entry level of recruitment as Assistant Professor to persons possessing the degree of Ph.D. awarded in a relevant discipline by the University following the process of admission, registration, course work and external evaluation as prescribed per the UGC norms.
- (iv)M. Phil. Degree holders at the time of recruitment to the post of Assistant Professor shall be entitled to 2 non-compoundable advance increments.
- (v) Minimum requirements of qualifications and/of experience may be relaxed in respect of exceptionally outstanding candidate. The University reserves the right to fill up or not to fill up any or all the posts or to shortlist and select the candidates in any suitable position depending upon the qualification and experience required for the said post.
