## TERMS AND CONDITIONS FOR PROVIDING TAXIS TO NIEPA

#### Tender Related:

1. The agency should quote its lowest rate in rupees in the enclosed proforma ONLY for various types of vehicles & component of services as noted on the proforma.

2. The firm should be registered with relevant regulatory authorities (Certificate of Incorporation,

Registration with GST.); (Attested copies of Registrations to be enclosed).

3. The firm should have at least 08 nos. of taxis of model not before 2014 registered in the name of firm; (Attested copies of Registration Certificates to be enclosed) with Bharat IV pollution cleared norms.

4. The firm should have similar experience during last two financial years in Government Sector/PSU etc.; (Attested copies of award letters of contract to be enclosed).

5. Bid sha!l be valid for a period of 60 days, extendable once only for 30 days with the approval of competent authority.

6. The tenderer should have an authorized Taxi Stand, located within the neighborhood/vicinity

of NIEPA Sri Aurobindo Marg, New Delhi.

- 7. The NIEPA reserves the right to reject all or any of the quotations, and decision of Registrar, NIEPA in the matters shall be final/binding. In case of poor services rendered by the Taxi Stand, the contract is liable to be cancelled with an intimation of seven days.
- 8. While quoting rates, the agency should note that the Institute may require transport services basically of following mode.
  - a. NIEPA to local destination in Delhi
  - b. The taxi stands within a radius of two to three kilometers of NIEPA are preferred due to minimize the travel billing, therefore Rs.40 to Rs.50 from stand to NIEPA will be paid and thereafter the actual travel mileage will be taken into account.
  - Taxi stand should be located within 2 to 3 kms. of NIEPA and travel to the local destination in Delhi will be treated for making minimum payment to the taxi. The taxi should be provided within 10-15 minutes and no advance bookings of Taxis will be made. Only in case of requirement of more than two to three Taxis, the advance bookings will be made with the Taxi Stand. The starting time/rates from the most nearest Taxi Stand of NIEPA and the meter reading will be accepted accordingly.
  - d. The agency will not provide any personal vehicles to NIEPA.
- 9. The agency should deposit EMD of Rs. 10,000/- (Refundable) in the Institute's account directly and enclose proof of the same in the 'Technical Bid'

10. The courts at Delhi alone shall have the jurisdiction in any matter arising out or relating to or touching this tender.

#### **General Terms Conditions**

- 1. The taxis should be in very good working condition and well maintained during the contract period. The taxis to be deployed should be in excellent condition mechanically as well as get up wise i.e. outer body / upholstery etc.
- 2. The Taxis deployed provided to the Institute should be of model not before 2014.
- 3. The firm should be in a position to supply taxies on short notice (within 10-15 minutes) as and when needed.
- 4. All expenses will have to be borne by the firm in case of breakdown of the Taxis deployed. Immediate replacement of the breakdown vehicle will have to be provided. The owner/firm shall provide standby vehicle in case of any breakdown immediately.
- 5. The owner/senior representative of the firm should be available round the clock on his own direct telephone (office as well as residence) and on mobile so to respond to the call for vehicles in emergent cases. The Mobile number should also be given.
- 6. All the charges towards repair/servicing, salary of the Driver, petrol expenses or any other incidental expenses on operation & maintenance of the hired car would be borne by the owner of Taxi Stand on whose name the contract for supply of Taxis is awarded.
- 7. The vehicles deployed by the firm may be required to ply in Delhi & NCR areas, such as NOIDA, Ghaziabad, Gurugram, Faridabad and therefore, vehicles deployed should have valid permit to run in the all such areas.
- 8. Service taxes will be reimbursed along with the hiring charges bill. The bills raised by the firm should have all tax registration numbers printed on the bills.
- 9. The vehicle should be insured in all respects by the firm. All liabilities arising out of any legal dispute, accidents, etc. shall be borne/ paid by the firm and NIEPA shall not be a party or liable in any matter whatsoever.
- 10. Legal disputes, if any arising during the currency of the contract, shall be Jurisdiction of Delhi only.

## **Debarring Conditions:**

- 1. No vehicle should be supplied having registration in the Name of employee of NIEPA or his/her close relative and a certificate to this effect be given on the body of bill while submitting claim.
- 2. No sub-contracting of the Service allotted is permissible by NIEPA. The near relatives of NIEPA employees either directly recruited or on deputation/contract are prohibited from participation in this tender.
- 3. Service Provider shall not engage any person below 18 years of age.

## Penalty for breach of terms & conditions:

- 1. In case a vehicle is requisitioned and the same does not reach at the appointed time and juncture, NIEPA will be free to call another vehicle from the open market and the expenses on this account will be deducted from the pending Bills/Security etc.
- 2. In case of delay in reporting, a penalty of Rs. 200/- per instance shall be imposed.
- 3. If the vehicle provided by the Services Provider is found to be not in good condition, the vehicle may be rejected and sent back.
- 4. The contractor shall not refuse to provide vehicles against NIEPA's requirement and on each refusal a penalty of Rs. 200/- for each refusal/non-providing of vehicle shall be imposed.

- 5. The penalty imposed will be deducted from the corresponding monthly pending bills or security deposits.
- 6. An agreement will be extended on Rs. 100/- non judicial stamp paper.

#### **Other Miscellaneous Conditions:**

The Service provider should comply with the following:

- 1. **Telephones** Telephone Numbers for requisition of vehicles (24x7) must be specified in the bid.
- 2. **Parking /Toll Charges**, Parking/ Toll charges if any, paid while performing duty may be claimed by Producing valid parking/ Toll slips along with monthly bills.
- 3. **Experienced Driver:** Service Provider shall provide qualified and experienced licensed drivers who are well conversant with Delhi/NCR roads, traffic signs and rules. Safety and security of the officers/ officials, while on board, will be the responsibility of Service Provider.
- 4. **Verification of Drivers**: The character antecedents of drivers to be deployed should be properly verified and their details (name, addresses, telephone nos., photograph, copy of driving license etc.) will have to be provided to this Institute.
- 5. **Duty Slips:** Duty slips in duplicate serially numbered shall be got signed by the user officer/officials at the end of duty/journey.
- 6. **Vehicles Up-keep:** Service Provider shall provide vehicle in good condition along with good and clean seat covers and curtains.
- 11. Vehicles will be hired on daily as well as monthly basis as per the requirements of NIEPA. Charges will be paid as follows.

i) Daily basis

80 Kms - 10 hrs.

40 Kms. - 05 hrs.

ii) Monthly basis

1800Kms.- 300hrs.

Additional charges will be paid as follows:-

i) Daily basis

Over and above 80 Kms – 10hrs. (for each additional km. - hr.)

Over and above 40 Kms – 05 hrs. (for each additional km. - hr.)
