ORDER

- (a) The appellant has filed first appeal No. Appeal No.NUEPA/A/E/25/00002 dated: 16.04.2025 Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. RTI No. NUEPA/R/E/25/00003 dated: 07.01.2025 against the Central Public information officer (CPIO) (hereinafter referred to as Respondent) of the NIEPA.
- (b) The submission in the RTI Appeal is "Provided incomplete, Misleading or False Information".
- (c) The Appellant has informed in the instance appeal that "Prayer or Relieve Sought. The reply of part I of my RTI application is not furnished. The reply of roster register based on two hundred point basis is to be furnished as approved UGC and same to be uploaded on university website. The detail of accounts of university where money for photocopies charges to be deposited. The link of website mentioned in your reply is general nature, specific link where the information is uploaded."
- (d) The appellant vide email dated April 17, 2025 was informed to appear for hearing in the office of the FAA on 22.04.2025.
- (e) The appellant neither respond to the email nor appeared for the hearing, hence the matter was decided ex-parte.
- (f) The reply of the Respondent (CPIO) in the instant appeal is as under:
 - It is submitted that the information sought by the Applicant (Appellant here in after) in response to his RTI Application No. NUEPA/R/E/25/00003 dated: 07.01.2025 was duly replied.
 - 2. Regarding two hundred UGC approved roster, the NIEPA has not have that much approved posts thus such record cannot be created.
- (g) This office has carefully considered the application, the response, the appeal and the records made available and the matter was decided based on the material available on record.
